

Mappleton Parish Council Minutes of the Meeting held on the 10th of May 2022, in the Maple Garage Showroom (By kind permission of Graham & Janet Burton)

Minutes March 2022 minutes were agreed as a true and correct record of what took place.

Matters Arising: Terry Weaver has been to look at Hatfield Lane, Mappleton, Cllr Janet Burton reported that another part of the road is collapsing.

Ward Cllr Barbara Jefferson commented that highways ERYC are extremely busy at the moment with planned road closures and repairs in the area.

Police Report: No one present.

Cllr Shawn Mars reported of a car that had been stolen in the Rolston Road area of Hornsea, the house had been burgled whilst the occupants were asleep, other items had also been taken from the house.

There has been a car fire on the main Cowden Road, the road was closed whilst the Fire Brigade attended.

Willow Garth: Nothing to report.

Accounts for Payment: Clerk's Fees £300.00, this was agreed.

Witherwick Community Wind Farm: Cllr Kim Baish not present.

Planning: Planning permission has been granted for the extension to Cowden Caravan Park 21/04682/STPLF. This has been granted with a substantial number of conditions.

Platinum Jubilee: A grant for £495.00 has been awarded to Mappleton Parish Council, to commemorate the Queen's Platinum Jubilee.

Three different designs of mugs were viewed by the Councillors and a decision made on the one to go forward with. There will also be a commemorative coaster, which was also available for the Councillors to approve.

It was thought that 120 mugs and coasters will be produced for the available money.

All houses on the Electoral Register will receive a mug and coaster, the properties within Mappleton will have theirs delivered by the people from Grey's Farm that are supplying them.

A system will have to be run to record who has received the commemorative gifts.

AOB: Cllr Janet Burton read out an article that had appeared in the Hornsea Gazette on the 31st of March 2022. The article stated that ERYC would receive part of a £36 million investment to explore innovative approaches of adapting to the effects of coastal erosion.

It was agreed to put Coastal Erosion on the agenda for the next Parish Council meeting, in order to formulate a written response.

There was a lively discussion about this topic, reflecting the concerns within the Parish.

Cllr Sue Earle reported that she has acquired some of the plants for the planting scheme, for the Parish. Clematis in Red, White, and Blue to commemorate the Queen's Platinum Jubilee are to be planted along the perimeter fence at the front of the All Saints Church, Mappleton. It was thought that the plants will be better planted inside the Grave Yard, to protect against being strimmed down

Jim Froud asked who cleans the toilets on the Cliff Top Car Park, as a visitor to Mapleton has commented about the exceptional high standard of the cleanliness that has been achieved. The lady would like her comments to be passed on to the person responsible, Ward Cllr Barbara Jefferson to make enquiries.

Cllr Graham Burton commented about the badly faded road markings, in the area, making it hard to read them in the dark.

Communities to trial innovative ways of adapting to coastal erosion

THE East Riding is to receive part of a £36 million investment to explore innovative approaches of adapting to the effects of coastal erosion.

As part of the Government's £200 million Coastal Transition Accelerator Programme, East Riding Council will receive funding to help its communities on areas of the coast that cannot sustainably be defended from coastal erosion.

Residents will be supported to prepare and plan for the long term, while also trialling some immediate actions that support the long-term resilience of coastal communities, including improving and replacing damaged infrastructure, such as beach access or transport links, and replacing at-risk public buildings with removable, modular or other innovative buildings.

Land in coastal erosion zones will be repurposed for different uses such as temporary car parks and restocking and treating habitats to include green buffer zones.

The scheme will also include working with the finance and property sectors to help move communities from the highest-risk areas, and developing the local planning system so it supports the managed transition of communities from high-risk land and restricts future development in areas affected by coastal erosion.

The Environment Agency will manage the programme, supporting the area as it develops and delivers its local projects. It will also ensure that ongoing learning is shared with other areas facing similar challenges.

Floods minister Rebecca Pow said: "As climate change brings more extreme weather, we must redouble our efforts to build a more resilient nation. We have ramped up flood and coastal erosion policies, and we will always defend our coastline where it is sustainable and sensible to do so. Where it isn't, we will support communities to adapt."

The programme will run to March 2027.

exploring and testing innovative opportunities.

A full evaluation of the programme will help to inform future national policy direction and will add to coastal resilience activity elsewhere, which includes a national coastal erosion risk map providing clearer data about local risks to help local planning, and the ongoing national refresh of existing shoreline management plans.

Emma Howard Boyd, chairman of the Environment Agency, said: "England's coastline has never been static. Today, 9,000km of open English coast is at risk from sea flooding, erosion, and landslips, and by 2100 once-a-century sea level events are set to become annual events."

"As a minimum, we need to plan for at least a metre rise of sea level rise by the end of the century. In some places the pace and scale of change may be so significant that, over a period of time, coastal authorities will need to help local communities transition away from the current shoreline over time."

"This programme is about providing that local support while increasing the whole country's expertise and resilience in the face of climate and coastal change."



HIGH-RISK: East Riding Council will receive funding to help communities in areas that cannot sustainably be defended from coastal erosion

The East Riding will benefit from the funding alongside North Norfolk, which between them include 84 per cent of the properties at risk of coastal erosion in England over the next 20 years. Councillor Jonathan Owen, leader of East Riding Council, said: "Valuing our environment, tackling climate change, safeguarding our heritage and countryside while developing our infrastructure remain key priority areas for the council and on that basis, we very much welcome this announcement."

"Our coastal communities are vitally important to the East Riding and residents will be supported to prepare and plan for the long-term impact of climate change, while also trialling some immediate actions that support the long-term resilience of communities near the coast."
