

# Mappleton Parish Council Minutes of the Meeting held on the 4<sup>th</sup> May 2021, in the Maple Garage Showroom (By kind permission of Graham & Janet Burton)

**Present:** Cllr J. Burton, Cllr G. Burton, J.Froud(Clerk), Cllr K.Baish, Cllr S.Mars, Cllr C. Taylor, Cllr J. Warrington, Cllr S. Earle, Ward Cllr B. Jefferson, Ward Cllr J. Whittle

**Apologies:** None.

**Minutes** May 2021 minutes were agreed as a true record.

**Matters Arising:** Cllr Janet Burton reported that the potholes down Hatfield Lane have been repaired, thanks to Ward Cllr Barbara Jefferson for her help.

**Police Report:** No one present. There have been several business properties broken into in Hornsea, another 2 last night.

There has been a lot of these type of break-ins recently, thought to be possibly the same people.

The Police seem to be having problems catching these people, it was thought that they could be getting away down the old railway lines.

Cllr Kim Baish reported that the WWFF had given £6,000.00 to have CCTV cameras put up in Hornsea, these are monitored by Hornsea Town Council.

There was some mention of Cameras being placed on the old railway line, but it was not known where the funding would come from, and how effective it would be.

**Willow Garth:** Nothing to report.

**Accounts for Payment:** Clerk's Fees £300.00, Maple Garage £30.00. This was agreed.

**Withernwick Wind Farm Grant:** Cllr Kim Baish suggested a Planting scheme, which would benefit the community of Mappleton Parish. Ideas were voiced, it was thought planters were not good as they would need watering. Cllr Kim Baish, Ckllr Shawn Mars, Cllr Janet Burton, and Cllr Sue Earle to meet at Coastal Retreat 17<sup>th</sup> August 2021.

The disused Phone Box was brought up at Church Mount, this has already been adopted by Community Heartbeat, but the Parish Council can buy it for a fee of £25.00 plus VAT.

Cllr Jim Warrington thought that it should be bought, and worry about what to do with it later.

A vote was held, it was passed to purchase the Telephone Box.

Ward Cllr Barbara Jefferson said that if Joanne at Hornsea Town Council is contacted, she may have information of a man that would carry out repairs to the Telephone Box.

Cllr Sue Earle passed a donation of £40.00 to Jim Froud to purchase the Telephone Box for the Parish.

**Witherwick Community Wind Farm:** Cllr Kim Baish reported that 24 Parishes ( Coniston have not responded) are interested in accepting the Parish Grant Award of £1,000 which is great news. The Clerks have been very positive, and some are keen to apply to the main fund once COVID restrictions are lifted.

I am currently processing the Parish Grant payments and this commitment will be on the next financial statement. The End of Grant reports showing what each Parish has spent the money on are due March 2022.

Small grant applications have increased recently and thank you for your support and time responding to all the e-mails. The panel have awarded £4,116.17 since the last panel meeting (see below).

**Planning:**

**Proposal:Variation of Condition 1 (restoration of site) of planning permission**

**19/03838/STPLF - Siting of buildings with change of use of agricultural land and hardstanding (for a period of not more than 1 calendar year) to piling test site for research and development of offshore wind turbine foundations and following conclusion site will be reinstated as agricultural land**

**Application type:Strategic - Variation of Condition(s)**

Cllr Kim Baish reported an increase in heavy wagons to this site.

No objections raised.

**Parishioners Questions:** An offer of books by Matty (member of the public) if the telephone box is to be used as a Library.

**AOB:** Jim Froud had passed around a quotation from Community Heartbeat Trust, for the installation of a Defibrillator in the disused Telephone Box, this was rejected as too expensive. Jim went on to say that a grant had been sort from the WWFF by the Parish Council for £500.00 for costs associated with the installation of a Defibrillator, this had been awarded. Cllr Kim Baish told of the problems of finding volunteers to do the training and to take responsibility for the Defibrillator, in his opinion he would rather give monies to the first responders. The Councillors decided to shelve the idea of a Defibrillator in the Telephone Box, and to re-pay the grant money of £500.00 to the WWFF.

The issue of a Defibrillator in Mappleton could be addressed again if the parishioners come up with a clear plan, and leadership of how the Defibrillator would be funded, maintained, and monitored.

The new Parking Restrictions in Mappleton seem to be a success, there have been 2 complaints from residents without driveways living in Cliff Lane, they have been advised to write to Traffic Management ERYC.

Ward Cllr Barbara Jefferson highlighted the problem of no yellow lines from Grey's Farm to Glebe Farm, coming into Mappleton on the left hand side of the road. It makes visibility impossible if vehicles are parked on this stretch as the road rises, and there is a corner in the road. This needs reporting to Traffic Management ERYC.

The problems associated with the parking of car transporters at Church Mount is ongoing, Jim Froud to contact ERYC.

Cllr Sue Earle complained that the Village Walkabout never comes to Cowden, there are massive problems with parking down Eelmere Lane, Cowden. It was not known if the cars are parked on public or private land, Sue is experiencing great difficulties accessing the Lane.
