Matters Arising: A letter of thanks has been sent to Mark Wilson who is making such a great job of cleaning the public toilets at the Cliff Top, Mappleton. Thanks to Ward Cllr Barbara Jefferson for obtaining the information.

An e-mail from Ward Cllr Barbara Jefferson had been forwarded around the councillors, outlining the correct recorded response time from the Fire Brigade, for the recent car fire at Cowden.

The Queens Platinum Jubilee Mugs and Coasters to commemorate the occasion have been delivered to all but 2 houses in Mappleton, Cllr Janet Burton to assist with one of the properties.

Cllr Shawn Mars has delivered at Rolston Seats, but has been unable to locate two properties.

Proposal: Variation of Conditions 5 (number of caravans and pods) and Condition 6 (approved plans) of planning permission 20/03990/STPLF (Change of use of land for the siting of touring caravans, serviced pods and amenity building and construction of lake, roads and drainage infrastructure following demolition of existing redundant agricultural buildings) to allow for the inclusion of static caravans in addition to touring caravans and pods

Applicant: Mr Robert Flannigan

Application Type: Strategic - Variation of Condition(s)

The application was for changing some pitches for touring caravans to accommodate static caravans, there is to be no increase in numbers.
