**Proposal: Erection of Replacement General Purpose Building following demolition of existing.**

**Location: Rainbows End, Little Lane, Cowden, HU11 4UQ**

**Applicant: Mr A Hayes**

**Application type: Full Planning Permission**

Alan Hayes was present at the meeting and gave a small presentation of his needs for the improved building on one level. Alan has knocked a number of older buildings down to make way for the new building.

Councillor Kim Baish Neighbors this property and spoke highly of what Alan was trying to achieve.

No objections raised, the Parish Council voted unanimously to approve the planning application.

**Proposal: Erection of reception/administration office building and associated alterations to car parking and removal of existing office mobile building**

**Location: Willow Garth Care Village Main Road Rolston East Riding Of Yorkshire**

**HU18 1XH**

**Applicant: Mr J Weldrick**

**Application type: Full Planning Permission**

After discussion the Parish Council voted unanimously to object to this planning application, and request that it is brought before the Eastern Planning Committee. Infrastructure concerns were raised, along with behaviour of

residents in public places causing nuisance.

**Parishioners Questions;** Mrs Rita Leonard addressed the meeting regarding the Old RAF Building at Cowden Bombing Range. Rita is looking for ideas for a use of this redundant building, that is of considerable size. An action group has been formed “The Cowden Range Group” and they are actively looking at a scoping exercise for the building. Documents were handed to Jim Froud for circulation around the Councillors, Rita Leonard to provide an electronic copy for ease of distribution.

Questions were asked about the Old Chapel in Mapleton, enquiries have not led anywhere, it is not known as to the full content of the Trust Deed. One enquiry has been referred to the Charity Commission for information.

**AOB;** Cllr Shawn Mars reported threatening behaviour towards a resident of Cowden, with mention of a knife being involved, and wanted to know if the Parish Council could help. It was thought that this was a Police matter and should be reported accordingly.

Jim Froud reported about the recent visit by Cllr Sue Earle and himself to Brimstone UXO at Cowden Bombing Range. An in-depth presentation and tour of the site was held, practice explosions were also demonstrated. It was a great opportunity to meet with the management of Brimstone, and representatives from the MOD, ERYC, and Emergency services.

Since February 2021 to September 2021 approximately 34,000 items of Ordnance have been removed from the beach. The site has to remain open to the public, so awareness is key, as not to tamper with or remove ordnance from the beach.

Brimstone have offered a visit to the beach for Parish Councillors by arrangement.
