**Present:** Cllr J. Burton, Cllr G. Burton, J.Froud(Clerk), Cllr K.Baish, Cllr S.Mars, Cllr C. Taylor, Cllr J. Warrington, Cllr S. Earle, Ward Cllr B. Jefferson.

**Apologies:** Ward Cllr J. Whittle.

**Minutes** March 2021 minutes were agreed as a true record.

**Matters Arising:** Further to the recent Proposed Parking Scheme at Mappleton, ERYC have written to all residents notifying of an Experimental Traffic Regulation Order. The scheme will run for a period of 18 months, in which time residents will be able to raise any concerns and any problems that may arise.

This is a pilot scheme running alongside consultation for 18 months, this is totally unheard of, Ward Cllr Barbara Jefferson has worked doubly hard to help the Parish achieve this result.

The Police and Officers of ERYC have been very supportive, acting quickly and decisively.

Once the restrictions are in place (thought to be before summer), there will be visits by Traffic Enforcement, who will have powers to remove vehicles where necessary.

Cllr Janet Burton commented about the recent planning approval for Sea View Caravan Park, there seems to be no mention of how many months a year that the site may operate.

Ward Cllr Barbara Jefferson commented that the operating licenses would have to be applied for, these will be advertised in the local papers. It is important that people raise their concerns, by writing to the relevant authorities within the planned consultation time. It was thought that no direct correspondence will come to the Parish Council.

In the Planning Consent a footpath from the site to Mappleton has to be constructed before all other works, there were concerns over how this will be achieved.

Cllr Janet Burton reported that a static caravan has arrived at Rolston, the bungalow was thought to be Driftwood, Hornsea Road, Ward Cllr Barbara Jefferson to sort.

Cllr Sue Earle commented about the coastal erosion measurements, she thought that it was time that we had some new information. Ward Cllr Barbara Jefferson to contact the relevant Officer.

**Police Report:** No one present. There have been several business properties and cars broken into in Hornsea over the bank holiday weekend, nothing of any value has been reported missing but they have made an awful mess.

There is a new Police Inspector for Hornsea and surrounding area, Derek Hussain who comes from the Metropolitan Police. He will cover 5 Parishes in North Holderness area, and will come in blind, as to what is going on.

He is tasked with loosing 5 PCSO's from Hornsea and Driffield, 2 that covered Hornsea are thought to be moving to the Hull area, the decision has not gone down well with the Officers concerned. Ward Cllr Barbara Jefferson is not at all happy with this outcome and has written a letter.

Lee Marshall is coming back to the area, this is welcomed as he already has good knowledge of the area.

**Willow Garth:** Nothing to report.

**Accounts for Payment:** Clerk's Fees £300.00, Maple Garage £40.00. This was agreed.

**Withernwick Wind Farm Grant:** A grant of £1,000.00 has been offered to Parish Council's in the area to help boost the economy, and hopefully make people feel better about their area. A scheme would have to be put in place, Cllr Kim Baish will be contacting Councillors for their ideas. The Parish Council have to register an interest before the end of May, the Councillors agreed to accept the grant. Cllr Shawn Mars was in favour of making plans and would assist Kim, in coming up with a scheme.

Cllr Janet Burton commented that the amount of £1,000.00 was not a great deal of money when you consider that Mapleton Parish has Cowden, Rolston, Rolston Seats to take into consideration.

Cllr Kim Baish commented that a scheme could be started in this financial year, and then more monies could be applied for in future years.

**Witherwick Community Wind Farm:** Cllr Kim Baish reported that he would submit a report to Jim Froud later in the week to be distributed around the Councillors.

**Planning:** None.

Cllr Janet Burton commented “ would it have made any difference if there were any applications”. This comment was made after Councillors are not very pleased with the planning process, and the amount of planning that is awarded retrospectively.

**Parishioners Questions:** There has been 2 bad accidents at Rolston bends, one thought to be speed related, and the other the driver was thought to be under the influence of alcohol.

**AOB:** The use of Zoom by Parish Council's is not permitted after the 7<sup>th</sup> of May 2021, so future meetings will have to be physical. Cllr's Janet Burton and Graham Burton said that the Parish Council can use the Garage Showroom.

Cllr Janet Burton reported a massive Pothole between Broom Hill and Hatfield, near to Mount Pleasant Farm on Hatfield Lane, JF to report.

Cllr Kim Baish reported that Mapleton All Saints Church will be open on Thursday 6<sup>th</sup> May for the Police Commissioner Election.
