

# **Mappleton Parish Council Minutes of the Meeting held on the 6th of September 2022, in the Maple Garage Showroom (By kind permission of Graham & Janet Burton)**

**Minutes** June 2022 minutes were agreed as a true and correct record of what took place.

**Matters Arising:** Cllr Janet Burton reported that she has not been able to look into the Village Hall, this will now go to the next meeting.

Cllr Sue Earle reported that she had acquired the clematis plants for the church yard, these have now been moved to Cllr Shawn Mars premises for safe keeping. Cllr Kim Baish will cut the holes for the plants, and Cllr Shawn Mars will spray the grass with weed killer.

**Police Report:** PCSO Adrian Clark and PCSO Alan Roberts were present at the meeting, they have taken over in the Hornsea area. They are aware of the parking problems in Mappleton, and have contacted ERYC traffic wardens on several occasions about the problems.

Councillors reported problems of parking down Hatfield Lane where there are no yellow lines.

Cllr Janet Burton spoke of the problems caused, South of the village with cars parking over the pavement obstructing access for pedestrians.

The Councillors were urged to contact 101 when these problems occur, and if Adrian and Alan are on duty, they will attend.

Litter and Dog Dirt have been a major issue this summer.

A shed at the end of Cliff Lane has been broken into, nothing was reported stolen, as the shed is empty.

**Willow Garth:** The Police are attending the residential homes on a regular weekly basis, their main concern is residents going missing.

**Accounts for Payment:** Clerk's Fees £300.00, Maple Garage Fuel £80.00 this was agreed.

**Witherwick Community Wind Farm:** Cllr Kim Baish reported that a meeting had been held in August 2022.

Kim was very disappointed with the outcome of the meeting. There had been 3 proposals for funding, and all 3 had been turned down. There is a substantial amount of money held in the fund, and is increasing because projects are not being funded.

The panel is represented by most of the surrounding villages, there seems to be some unrest as some members have recently resigned.

It was thought that a request for minutes of the meetings should be made to ERYC who oversee the proceedings.

**Planning:** None at the present time.

**Bulb Planting:** The Community Service workers are now out of Covid-19 restrictions, and are resuming carrying out tasks in the community. Simon from the service would like to come out and survey where the planting is to take place, Cllr Kim Baish has kindly agreed to meet him.

Cllr Sue Earle will be acquiring the bulbs this week.

**Coastal Erosion:** The article that appeared in the Gazette in March was discussed, 36 million pounds for an

initiative for coastal defences to run until 2027. It was thought that this is a total waste of money, and would be better spent on the coastal defences. The thoughts were that defences are needed, Jim Froud to contact Ward Cllr John Whittle to acquire the e-mail address for the relevant people to contact with the Parish Council's concerns.

**Paristioners Questions:** Questions were raised about the state of the footpath between Mappleton and Cowden, it was thought that this work will be carried out in this financial year.

The Road Repairs on Hatfield Lane are reported to be sub-standard, not filled in properly.

The finger post at the junction of Hatfield Lane and the B1242 needs repairing.

Jim Froud to report to Terry Weaver Highways ERYC.
