

Mappleton Parish Council Minutes of the Meeting held on the 8th July 2025, in the The Old Post Office, Tearooms, Cliff Lane, Mappleton, HU18 1XX, by kind permission of Katie Stones.

Present: Cllr S. Mars, J.Froud(Clerk), Cllr K Baish, Cllr S.Earle, Ward Cllr B. Jefferson, Ward Cllr J. Whittle 4 members of the public.

Apologies: Cllr C. Taylor, Cllr J Burton, Cllr G Burton, Cllr J Warrington..

Minutes May 2025 minutes were agreed as a true and correct record of what took place.

Matters Arising: Cll Kim Baish asked if there was any funding available to help with the costs of IT equipment for the Clerk, who is relied on more and more to be up to date with equipment.

Cllr Sue Earle complained in a strong manner as to what was happening with the Silhouette Servicemen purchased for the Parish over a year ago.

Cllr Shawn Mars relied by saying that 2 Silhouette's will go to Rolston, 2 to Mappleton and 2 to Cowden.

Cllr Sue Earle asked were the Silhouette Servicemen are now? Apparently 2 are in Ken Petch's front garden, and 4 are in a shed at Cllr Jim Warrington's farm.

Cllr Kim Baish arranged with Cllr Shawn Mars to fix the 2 Silhouette Servicemen onto the Bus Shelter at Cowden.

Cllr Sue Earle asked about the Coronation Bench, Cllr Shawn Mars replied by saying that this can't be put in situ until the Car Park is finished.

Cllr Sue Earle asked about the painting of the Telephone Box in Mappleton, the man that is going to do the job has badly injured himself. It was agreed that Cllr Shawn Mars will give the paint to Cllr Sue Earle, and she will find someone to carry out the painting.

Cllr Sue Earle asked about why the minutes are not being displayed in the noticeboards to let parishioner know about what is going on? Cllr Shawn Mars has the keys to the noticeboard, it was agreed that he will hand these to Cllr Sue Earle, and she will make sure that the minutes are displayed.

Police Report: No one present.

Accounts for Payment:

Clerk's Fees £350.00, Postage £8.70, Maple Garage £70.57, this was agreed.

Village Hall: Nothing

Witherwick Community Wind Farm: Cllr Kim Baish reported about the monies granted towards schemes this year so far, these are attached to these minutes.

Kim ran through the list of expenditure, the one thing that stood out is that no money has come to Mappleton, as no schemes have been submitted. Kim urged the people present to apply for money for schemes that will benefit the community.

Dave Rapley who was present at the meeting mentioned about having a Defibrillator in the Old Telephone Box, Dave is fully qualified to train people in the use of this type of equipment, and offered his services.

It was tought that a notice for the noticeboard should be displayed asking for people to come forward with schemes for funding from the WWFF.

Proposal: Siting of a static caravan for the purpose of shelter, washing facilities and dry storage of animal food/medication

Location: Land South West Of Coney Garth Bungalow Main Street Rolston East Riding Of Yorkshire HU18 1XH

Application Type: Full Planning Permission

This was discussed at length, and the Parish Council voted to Object to this planning application.

Willow Garth: Nothing.

Parishioner's Questions: The telephone box is being made into a library for the community and visitors to use. Some of the windows need replacing, Cllr Kim Baish will sort this.

The Coastal Changes meeting has been held, and it was noted that only 4 residents of Mapleton made the effort to attend.

15 million pounds has been put aside to be spent on Coastal Management over the next 2 years.

Several schemes have been investigated by Officers in Mapleton, nothing has yet been agreed.

Mapleton needs interest in this scheme, it is time for the community to come together to achieve this.

It was decided that Richard Jackson the ERYC Coastal Engineer will be invited to the next Parish Council meeting in September.

AOB:

A question was asked about a post made on social media that reported sewage being pumped into the sea at Mapleton. It was thought that this was fictitious, as the new water system in Mapleton is fully up and running, and all sewage is going through the new system.
