

Mappleton Parish Council Minutes of the Meeting held on the 9th July 2019, in the Maple Garage Showroom. (By kind permission of Mr & Mrs G Burton)

Present: Cllr J. Burton, Cllr S.Earle, J.Froud(Clerk) Cllr K.Baish, Cllr S.Mars, Cllr G.Burton, Ward Cllr J.Whittle, Ward Cllr B. Jefferson, 6 Members of the Public.

Apologies: Cllr C. Taylor

Minutes May 2019 minutes were agreed and signed as a true record.

Matters Arising: Kim Baish reported that the work to the damaged plaster work at the church has been completed.

Planning permission has been granted for the Annexe at the Old Post Office to be used as a holiday let. One of the conditions of the Planning permission is that;

The holiday cottage hereby permitted shall be first occupied until the space has been laid out for vehicles to be parked in accordance with the details hereby approved. The vehicle parking facilities shall thereafter be retained.

This condition is imposed in order to ensure that parking facilities are restricted in accordance with the requirements of National Planning Policy Framework whilst still avoiding the need for vehicles to park on the highway where they could adversely affect the safety of other highway users, thus minimising the risk to other road users.

The Councillors were pleased that the Planning permission had been granted, and that their concerns about the parking problems down Cliff Lane had been taken into account.

Dave Cook Waste and Streets Supervisor for ERYC has surveyed possible sites for bins on Eelmere Lane, Cowden. One could be sited at Cross Keys public house on Eelmere Lane, and one at the main entrance to the Cowden Holiday Park, on the side of the B1242.

The cost of the bins are £377.16 plus VAT, this is a one off payment, once sited ERYC will take over the maintenance and renewal as required. Shawn Mars to get approval for the cost from Cowden Caravan Park.

Ward Cllr Barbara Jefferson told the meeting of the new legislation for Sewage Discharges that will effect properties with septic tanks. This will effect properties on Eelmere Lane, Cowden. The acknowledgment is attached to these minutes.

Police Report: No one present. The Parish/Town News Release is attached to these minutes.

Willow Garth: No one present.

Accounts for Payment: Clerk's Fees £300.00, Maple Garage Fuel £62.00, Postage £7.32. This was agreed.

Witherwick Community Wind Farm: Kim Baish reported that their next meeting will be in October.

The sum of £500.00 has been granted to the Charity Shop in Aldbrough for new shelving.

Money will also be granted for the re-wiring of the Methodist Chapel in Aldbrough.

Kim urged people from Mappleton Parish to come up with projects that need funding, there is a pot of money that has to be spent.

Planning Matters: 19/01806/PLF. Conversion of existing detached garage to create a self-contained building to be used as a holiday let (part retrospective)

Location: Woodbine Cottage, Cliff Lane, Mappleton.

Applicant: Mr Adam Sibey.

Application type: Full Planning Permission.

Mr Adam Sibey gave his account of his plans for the holiday let, acknowledging that there are problems with parking down Cliff Lane, Mappleton.

Jim Froud read out the ERYC Highways summary of the Planning application to the meeting.
After in depth discussion, the Councillors voted unanimously to object to this planning application.

Nothing new has been presented, so the Councillors agreed unanimously to uphold their original written objection.

Parishioners Questions; Mrs Janet Burton from the Old Post Office brought up the problems experienced with people being frightened, when the ordnance is detonated on the beach. She has spoken with the bomb disposal officer, and he has agreed that a flag could be put up to warn the public.

Cllr Janet Burton asked who would be responsible for the flag and the flagpole, it was not known at the present time.

Mrs Janet Burton to contact Bomb Disposal to ask for more details.

Mrs Janet Burton asked if the Village could have a Defibrillator? Cllr Kim Baish commented that the WWFF have funded some for other villages in the area, and that they have to be renewed after 3 years.

Mrs Janet Burton is quite happy for the Defibrillator to be sited on the wall of the Old Post Office, Cliff Lane, Mappleton. The Councillors voted in favour of having one and instructed Cllr Kim Baish to action the plan.

Ward Cllr Barbara Jefferson reported to the meeting about the Bus Service 220 Hornsea -Bilton which has been stopped by EYMS because of the lack of use.

HART have been running the same service Monday – Friday but this will finish on the 12th of August 2019.

Hart will run a pre-book car service from this date, you must contact HART to book a place.

After a couple of months of falling criminal damages we have seen an increase to 7 in June. Usually this could be put down to increased alcohol intake, fuelled by balmy summer weather, however this month this has not been the case (with the weather) and these offences are detailed below.

Of particular note is that we have had only one theft reported to us in June. Whilst this may be the case that only one has occurred I would not like to think that it is because things are not being reported.

As a police Force, we use reported crime statistics to influence decisions on many things such as priorities and resourcing and it is important that the public report these crimes, however insignificant they may seem.

2. Crime Issues of particular note

We have had a number of damages this month these have included; the Seafront shelter near Floral Hall, a pushbike which was secured outside a property, a car which was dented after what appears to have been a drink fuelled incident and the roof of a building at Hornsea Secondary School after youths climbed onto it. Suspects have been identified for the school roof incident and will be dealt with by NPT and the ASB team at ERYC

There has also been 2 thefts from vehicle where drills and tools have been taken. Whilst it is not always convenient to remove all items out of a work van we would like to remind people to do this as tools are a common item to be stolen and it is best to try and avoid the situation rather than having to incur a great cost to replace them. There was also a theft of a license plate off a vehicle, please ensure your car's plates are secured, if they are stolen please inform Police as the thieves may well use them on other vehicles to be used in crime or run up parking or speeding ticket fees.
