

# Mappleton Parish Council Minutes of the Meeting held on the 9th of May 2023, in the Aldbrough Village Hall, Garton Road, Aldbrough.

Present: Cllr S. Mars, Cllr J. Burton, Cllr G. Burton, J.Froud(Clerk), Cllr J. Warrington, Cllr C. Taylor, Ward Cllr B. Jefferson, Cllr S. Earle, 1 member of the public.

Apologies: Ward Cllr J. Whittle.

Minutes March 2023 minutes were agreed as a true and correct record of what took place.

Matters Arising: Cllr Shawn Mars thought that the Coronation Bench could possibly be sited on part of the land that belongs to Maple Garage. This could be a possibility but the overall plans for this area have not been finalised.

Police Report: No one present.

There have been a lot of thefts of vans in Hornsea over the period. Three thefts of vans were reported, in Hornsea, one was found burnt out at Brandesburton.

In the area there have been thefts of GPS equipment from a farm on Hatfield Lane.

Clerk's Fees: Cllr Shawn Mars proposed an increase in the fees of £50/meeting to keep inline with rising costs. This was agreed.

Accounts for Payment: Clerk's Fees £350.00, Toners £20.00, Postage £6.00. This was agreed.

Kings Coronation: It was agreed to order the bench, which has a lead time of 12 weeks. Thoughts of the base were discussed, it was thought that a concrete plinth would be best. The cost of the bench will be approximately £850.00 plus VAT to include delivery and a commemorative plaque.

Witherwick Community Wind Farm: Cllr Kim Baish reported that there will be a meeting on Thursday the 18<sup>th</sup> of May 2023.

There has been an award of £1,000.00 to a small village for something to do with the King's Coronation, Kim has not been happy with the decision, as there was very little detail and what appears to be less than 50% of the members were present to vote. Jim Froud to contact ERYC to ask for details of the meeting, and a copy of the minutes that can also be forwarded to Ward Cllr Barbara Jefferson.

Planning: 23/01048/PLF

Proposal: Conversion of a redundant agricultural building to form a dwelling.

Location: Hill Farm Main Road Mappleton, HU19 1XR.

Applicant: Mr & Mrs M Basham.

Application Type: Full Planning Permission.

No objections raised. Voted to approve this Planning Application.

Village Hall: Cllr Janet Burton reported that a Bank account is needed to move on, this is all in hand.

Paristioners Questions: None.

AOB: The subject of a meeting venue was discussed, it was thought that long term the meeting should be held in the Mappleton Parish. Cllr Shawn Mars asked about the All Saints Church, Mappleton which is closed at the moment due to safety issues. Cllr Kim Baish welcomed the idea of using the church, but there is such a large

amount of work to be done, to bring it up to a standard to hold meetings.

The Tea Rooms on Cliff Lane have been sold, there might be a possibility of holding meetings there.

The Cross Keys Public House at Cowden was discussed, it was thought that they are closed on a Tuesday, so this could be ideal. Cllr Shawn Mars to enquire, for the next meeting.

Cllr Kim Baish reported the poor standard of work carried out to the new Coastal Path South of Cross Keys up to Cowden Lane, Cowden.

There has been no kerb put in, so vehicles have been running on the grass verge and dragging mud and debris onto the carriageway. The Drainage Grips have been filled with a shale like material, to make them level, this has caused problems with water drainage, to the extent that the junction of Cowden Lane and the B1242, has now got standing water. The hard standing on Cowden Lane, Cowden provided for Plant and Machinery storage whilst the works were being carried out needs removing.

An email will be sent to Terry Weaver requesting a meeting on site with Councillors and the Clerk to discuss the problems, as a matter of urgency, expressed by Ward Cllr Barbara Jefferson.

Cllr Janet Burton reported a lampstand missing outside of Maple Garage, it was thought to have been demolished by a Tesco wagon, but has not been replaced.

Cllr Graham Burton reported of speed limit warning signs that need cleaning at Cowden.

Cllr Jim Warrington reported that Cowden Caravan Park and Seaview Caravan Park have both connected their Sewerage into the main Sewer in Mappleton. Jim is concerned that this might overload the system, and result in Sewerage being discharged onto the beach.

Ward Cllr Barbara Jefferson commented, that they have written to Yorkshire Water expressing concerns over the connections, but as yet have not replied.

Jim Froud reminded Councillors about the Village Walk About on Wednesday the 31<sup>st</sup> of May 2023, 9.45am outside of All saints church, Mappleton.

Meeting closed at 8.45pm.
